

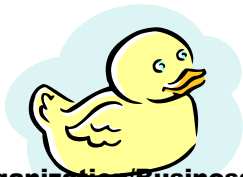

- Vendor is responsible for any and all **City, County, and/or State licenses, certifications and insurance requirements**. Any kind of consumable food/beverage booths must have appropriate permits from the Jefferson County Health Department , call 636-789-3372
- Cancellations or no-shows will result in forfeiture of all payments. **PAYMENTS ARE NON-REFUNDABLE!**
- Items not listed on this application may not be displayed or sold and may result in your booth being shut down and no refund will be issued.
- The Chamber reserves the right to refuse/remove vendors at our discretion.
- All booths must remain open to the public from 9:00am to 4:00pm on the day of the event. No early breakdowns.
- Only one business per booth unless otherwise authorized by the Chamber. No subletting your space to another vendor.
- Vendor is responsible for clean up of its space and you are kindly asked to leave the area as you found it.
- No electric. There is not much shade on Main Street, please bring Tents/Canopies!
